

COMMISSION DECISION

of [...]

on the awarding of grants for proposals for 2009 under the second Health Programme (2008-2013)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Decision No 1350/2007/EC of the European Parliament and of the Council of 23 October 2007 establishing a second programme of Community action in the field of health (2008-2013)¹, and in particular Article 8(2) thereof,

Having regard to the Commission Decision of 2 September 2008 SEC(2008) 2395 conferring delegated powers to implement the second programme of Community action in the field of health (2008-2013) to the Director-General of the Directorate General for Health and Consumers²,

Having regard to the Decision of the Director-General of the Directorate General for Health and Consumers of 9 September 2008 sub-delegating the exercise of delegated powers concerning decisions on the award of grants in the framework of the second programme of Community action in the field of health (2008-2013) to the Director of Directorate SANCO C "Public health and risk assessment".

Whereas:

- (1) The work plan for 2009 for the implementation of the second programme of Community action in the field of health (2008-2013) was adopted by the Commission on 27 February 2009 (Decision 2009/158/EC)³.
- (2) According to the work plan for 2009, the total indicative amount for the call for proposals for projects is estimated at EUR 24 130 500, the total indicative amount for joint actions by the Community and one or more Member States or by the Community and the competent authorities of other countries participating in the Programme is estimated up to EUR 7 239 000, the total indicative amount for operating grants is estimated at EUR 2 500 000 and the total indicative amount for conferences in the field of public health and risk assessment is estimated at EUR 1 100 000: EUR 300 000 for conferences organised by the Presidency of the Union and EUR 800 000 for other conferences.
- (3) A call for proposals 2009 was published on 26 February 2009 with a view to selecting proposals eligible for Community funding under the work plan for 2009.
- (4) This call for proposals consisted of the following parts:
 - a call for proposals for the award of a financial contribution to specific actions in the form of projects,

- a call for proposals for the award of a financial contribution to specific actions in the form of conferences,
- a call for proposals for the award of a financial contribution to the functioning of non governmental bodies and specialised networks (operating grants),
- a call for proposals for the award of a financial contribution to specific joint actions between the Commission and Member States/ participating countries

The deadline for submitting proposals under each call was 20 May 2009

- (5) In accordance with Article 116(1) of the Financial Regulation, an evaluation committee met on 1 and 2 July 2009 and drew up a list of projects deserving to receive Community co-financing in that they best meet the award criteria laid down in Commission Decision 2009/158/EC on the selection, award and other criteria for financial contributions to the actions of this programme, and a reserve list of projects that could be selected if appropriations were available.
- (6) The Committee of the second Programme of Community action in the field of health (2008-2013) "The Committee", at its meeting on 23 July 2009, issued a favourable opinion on the results of the selection procedure, with the exception of Joint Action, "the Green Lace healthy lifestyles campaign, reference number 101287 in Annex IV.
- (7) In view of the political importance attached to the promotion of healthy lifestyles in young people expressed by Member States and stake holders in the EU Platform on diet, physical activity and health and the High Level Group on nutrition and physical activity, as well as the need to preserve the investment committed by the Member States participating in the Joint Action in a period of economic crisis, and at the same time to ensure the development of meaningful pilot awareness raising activities on healthy lifestyles, it is necessary to depart from the opinion delivered by the Committee concerning the Joint Action "The Green Lace healthy lifestyles campaign". The Commission has informed the Committee of the manner in which the opinion has been taken into account.
- (8) Pursuant to Article 15 of the Commission's Rules of Procedure, the adoption of certain individual decisions on the award of grants may be sub-delegated to the competent Director, subject to the restrictions and conditions laid down in the implementing rules of the Commission's rules of Procedure,

HAS DECIDED AS FOLLOWS:

Article 1

Co-financing totalling EUR 23 328 525 is awarded to the projects set out in Annex I to this Decision, which comply with the principles and criteria laid down in Commission Decision 2009/158/EC, within the limits of the appropriations available under budget line 17 03 06.

Article 2

Co-financing totalling EUR 300 000 is awarded to conferences organised by the Presidency of the Union and EUR 858 568 is awarded to the conferences set out in Annex II to this Decision, which comply with the principles and criteria laid down in Commission Decision 2009/158/EC, within the limits of the appropriations available under budget line 17 03 06.

Article 3

Co-financing totalling EUR 2 488 156 is awarded to the operating grants set out in Annex III to this Decision, which comply with the principles and criteria laid down in Commission Decision 2009/158/EC, within the limits of the appropriations available under budget line 17 03 06.

Article 4

Co-financing totalling EUR 8 000 154 is awarded to the joint actions set out in Annex IV to this Decision, which comply with the principles and criteria laid down in Commission Decision 2009/158/EC, within the limits of the appropriations available under budget line 17 03 06.

Article 5

Three reserve lists for projects, conferences and operating grants which could receive Community co-financing within the limits of any available appropriations are established and set out in Annex V to this Decision, the order in which they are listed constituting the order of priority for each list.

If appropriations become available, they will be awarded to the reserve list of projects on a priority basis, in accordance with paragraph 2 of Annex I to Decision 2009/158/EC, taking into account the allocation of the budget to the other financial instruments.

Article 6

The grants to be awarded in 2009 to implement the second programme of Community action in the field of health (2008-2013) are approved in accordance with Annexes I, II, III, IV and V.
